#### PARTICIPATION:

Upon acceptance of your completed Registration Form and written confirmation from Farm Brew LIVE, the following Terms and Conditions will be in effect.

#### Nova LIVE AGREES TO:

- A. Provide the participants with a vendor space and vendor pass.
- B. Nova LIVE reserves the right to rearrange the floor plan at any time and/or relocate exhibitors should it become necessary in the judgment of the Event Coordinator(s).
- C. Items in the Festival tents are the responsibility of the exhibitor. Nova LIVE is not responsible for items that are stolen or lost.

#### THE EXHIBITOR AGREES TO:

- A. Promote and display only products that was on the vendor registration form.
- Present vendor pass to the vendor liaison prior to setup.
- C. Accept the location of the assigned space. Understand that assigned space may be subject to change at the discretion of the management team at Nova LIVE. All space location preferences will be given fair consideration.
- D. Not to share the assigned space with unauthorized vendors or personnel.
- E. Not to serve any form of alcoholic beverages to persons under the age of 21.
- F. Provide a qualified representative during the show duration.
- G. Refrain from dismantling the space before the move-out day and hours listed.
- H. Remove all materials from the Festival site no later than 7:00 PM on Sunday, September 21, 2025.
- I. Release Nova LIVE and Villagio Hospitality Group of any liability and/ or losses due to participation. This refers to late product shipments, in-transit damage, loss of samples and unauthorized removal of equipment or supplies at the end of the Festival.
- J. Complete all questions on the Registration Form no less than 10 days prior to the day of the event.
- K. Exclusivity is <u>not</u> guaranteed. It is possible, and in some cases probable, that companies offering similar products will participate in this event. Their locations may be near or next to one another. Nova LIVE will make every effort to place like companies apart, but it cannot be guaranteed.
- L. Exhibitor <u>MUST</u> provide a copy of their Health Department Permits, Insurance Certificate, and Business License no less than 10 days prior to the day of the event.
